WITNESSETH That in consideration of the sum of Fifty-Eight Thousand Five Hundred (\$58,500) Dollars in hand paid, the receipt whereof is hereby acknowledged, said Grantors do hereby grant and convey unto said Grantees, their heirs and assigns,
