Between PATRICK OZANICH and FRANCES O. HARPER, Co-Executors under the Last Will and Testament of Anna B. Ozanich, deceased, late of South Union Township, Fayette County, Pennsylvania, parties of the first part, GRANTORS,

AND

FRANCES O. HARPER and WILLIAM W. HARPER, her husband, of South Union Township, Fayette County, Pennsylvania, parties of the second part, GRANTEES.

WITNESSETH THAT:

WHEREAS, Anna B. Ozanich, late of South Union Township, Fayette County, Pennsylvania, died November 11, 2003, seized of a certain parcel of ground situate in South Union Township, Fayette County, Pennsylvania, being hereinafter more particularly described, having first made her Last Will and Testament, dated October 25, 1979, duly probated in the Office of the Register of Wills of Fayette County, Pennsylvania, on December 19, 2003, at No. 1056 of 2003, wherein she appointed Patrick Ozanich and Frances O. Harper Co-Executors above named, to whom Letters Testamentary were duly granted on December 19, 2003; and WHEREAS, the said Patrick Ozanich and Frances O. Harper, Co-Executors, Grantors herein, by virtue of the power and authority conferred upon them by the Act of the General Assembly of the Commonwealth of Pennsylvania, "Decedents, Estates and Fiduciaries", Section 3351 of 20 PA C.S.A., 1972, June 20, P. L. 508, No. 164, Section 2, effective July 1, 1972, as amended 1974, Dec. 10, P. L. _____, No. 293, Section 7, does hereby convey the within described premises to the Grantees.

NOW, THEREFORE, THIS INDENTURE WITNESSETH, that in

consideration of the sum of \$1.00, in hand paid, receipt whereof is hereby acknowledged, and by virtue of the power and authority aforesaid, said Grantors do hereby grant and convey unto said Grantees, as tenants by the entireties:

ALL that certain piece, parcel or tract of land situate in South Union Township, Fayette County, Pennsylvania, more particularly bounded and described as follows:

BEGINNING at a point in the line of land late of Isaac Brown, deceased, and land of David S. Richey, said point of beginning being South 41 ½ degrees West, 1299 feet from where the land late of Isaac Brown, deceased, and land of Abraham Brown corner in said line; thence by said land of David S. Richey, South 40 ½ degrees West, 165 feet; thence by land of said Brown, North 49 ½ degrees West, 132 feet; thence by the same, North 40 ½ degrees East, 165 feet; thence South 49 ½ degrees East, 132 feet to the place of beginning, Containing one-half (1/2) acre.

Ozanich, mother and natural guardian of Arthur Ozanich, et al., and recorded in said Recorder's Office in Deed Book 1106, Page 105.
