Bidders are responsible for palletizing, rigging, loading, and moving all items purchased without assistance from PRG or the Auction Company. Boxes / pallets / containers / packaging supplies are the responsibility of the Bidder. **WE DO NOT SUPPLY PALLETS**. Some items may be loose and not in road cases.
