WARRANTY DEED
(Individual to a Trust)

THIS DEED OF CONVEYANCE made and entered into this 12th day of May, 2011, by and between JERRY K. WORLEY TRUST U/A/D the 11th day of April, 2007, whose address is 460 South Banana River Drive, Merritt Island, Florida 32952, hereinafter referred to as "Grantee".

WITNESSETH that for and in consideration of the total sum of (\$1.00) cash in hand paid and other good and valuable considerations, receipt of which is hereby acknowledged, Grantor have bargained and sold and by these presents hereby grant, bargain, transfer, convey and warrant unto the Grantee, its successors and assigns forever all his right, title and interest in the following lands and property together with all improvements located thereon, lying the County of TODD, State of KENTUCKY, and more particularly described as follows, to-wit:

Jones about three miles Northwest of Allegre, Todd County, Kentucky; thence with the old road North 30° West 48 poles; thence same North 42° West 21 poles; thence same North 20° West 51 poles to a white oak tree on the East side of the road; thence leaving the road East 113 poles to a hickory and gum tree marked and standing in Hershel Edward's line; thence with Edward's South 10 West 60 poles to a marked hickory tree on a point of a large hill; thence along the top of a bluff South 3° West 17 poles to a corner with Mrs. I. D. Jones South 58° West 55 poles to the beginning, containing 43 acres, more or less.

GRANTOR and GRANTEE being duly sworn, do certify that the transfer effected in this deed shall not be subject to transfer tax based in KRS 142.050(8).

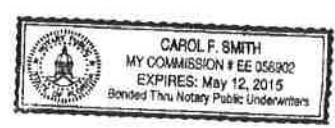
