2. Seekford owns that certain lot or parcel of land containing 1.245 acres, known as

Rockingham County, Virginia, adjoining the Billhimer tract described hereinabove and being the

identical real estate acquired by them by deed dated April 13, 2021, of record in the aforesaid

3. The Billhimer tract contains a well which supplies water to the Seekford tract and

the parties desire to create this shared well agreement under the terms described hereinafter.

## WITNESSETH:

That for and in consideration of the mutual benefits to be derived therefrom, Billhimer grants to Seekford the right to use water from the well and the parties agree as follows:

So long as the poultry houses on the Billhimer tract do not use any water from the of aforementioned well, then all costAmaintenance and repair shall be shared equally between Billhimer and Seekford.

However, if the poultry houses are in fact used for poultry production, then the percentages change so that Billhimer's share is eighty percent (80%) of repair and maintenance and Seekford's share is twenty percent (20%) of repair and maintenance of the well.

This agreement shall be binding upon the parties hereto, their heirs, successors and assigns.
