TERMS AND CONDITIONS

TERMS: The terms of the sale are cash or equivalent unless arrangements are made prior to the sale. Satisfactory settlement must be made with the clerk of the sale immediately after the close of the sale. Only when the above conditions are met will the buyer be entitled to the warranties listed below. Animals will be released only on a signed order from the clerk when presented to the barn superintendent. In no case will animals be released unless settlement is made with the clerk of the sale.

BIDS: The highest bidder shall be the buyer. In case of dispute, the animal shall again be put up for advance bids, and if there be no advance bid, the animal shall be sold to the person from whom the auctioneer on the stand accepted the last bid. In case two or more claim the bid, the auctioneer in the box shall indicate the party whose bid he recognized. Other claimants will be given an opportunity to increase the bid and bidding will be restricted to the two or more claimants. In all disputes the auctioneer's decision is final.

RISK: All animals are at the purchaser's risk as soon as struck off, but will be cared for free of charge for 24 hours. Purchasers must make arrangements for the care of their purchases beyond the 24 hour period. Animals are solely at the consignor's risk prior to selling in the event of fire or other eventuality.

SHIPPING: Assistance will be given in shipping the animals after the sale. All costs, risks, and responsibility will be borne by the purchaser.

REGISTRATION PAPERS: Registration papers for registered animals will be furnished to the buyers by the sellers after the payment has been cleared. Transfer fees will be paid by the seller. ID Grade identification certificates will be transferred at the buyers expense.

HEALTH WARRANTY: The seller will provide official health certificates when requested by the buyer. Cattle requiring TB & Bangs testing for transport will be done after the auction and cattle will be under the care of the original owners until such testing is completed. The results of any future health test is not guaranteed. No animal is warranted to be free of Johne's Disease or other infectious disease. The current herd vaccination program will be announced from the block.

PARTNERSHIPS AND SYNDICATES: In each case of a multiple-owned animal the individual owners reserve the right to bid.

ERRORS: The material in this catalog has been carefully edited. If any errors or omissions are discovered, they will be announced. Such announcements to take precedence over the matter of print in this catalog. Information believed to be correct but is not guaranteed.

GUARANTEE: It is the intention of the owners and sale management to represent and present these animals in their present condition. However, you are purchasing them on an "AS IS" basis with no warranties expressed or implied. No adjustments will be made after the animals leave the sale site. Females pronounced pregnant were found to be pregnant by a licensed veterinarian on the date announced. No guarantee is made or implied that the pregnancy will go full term. Open mature females are considered breeders by the fact that they have produced offspring. Open young females are presumed breeders.
