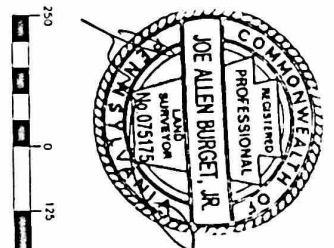


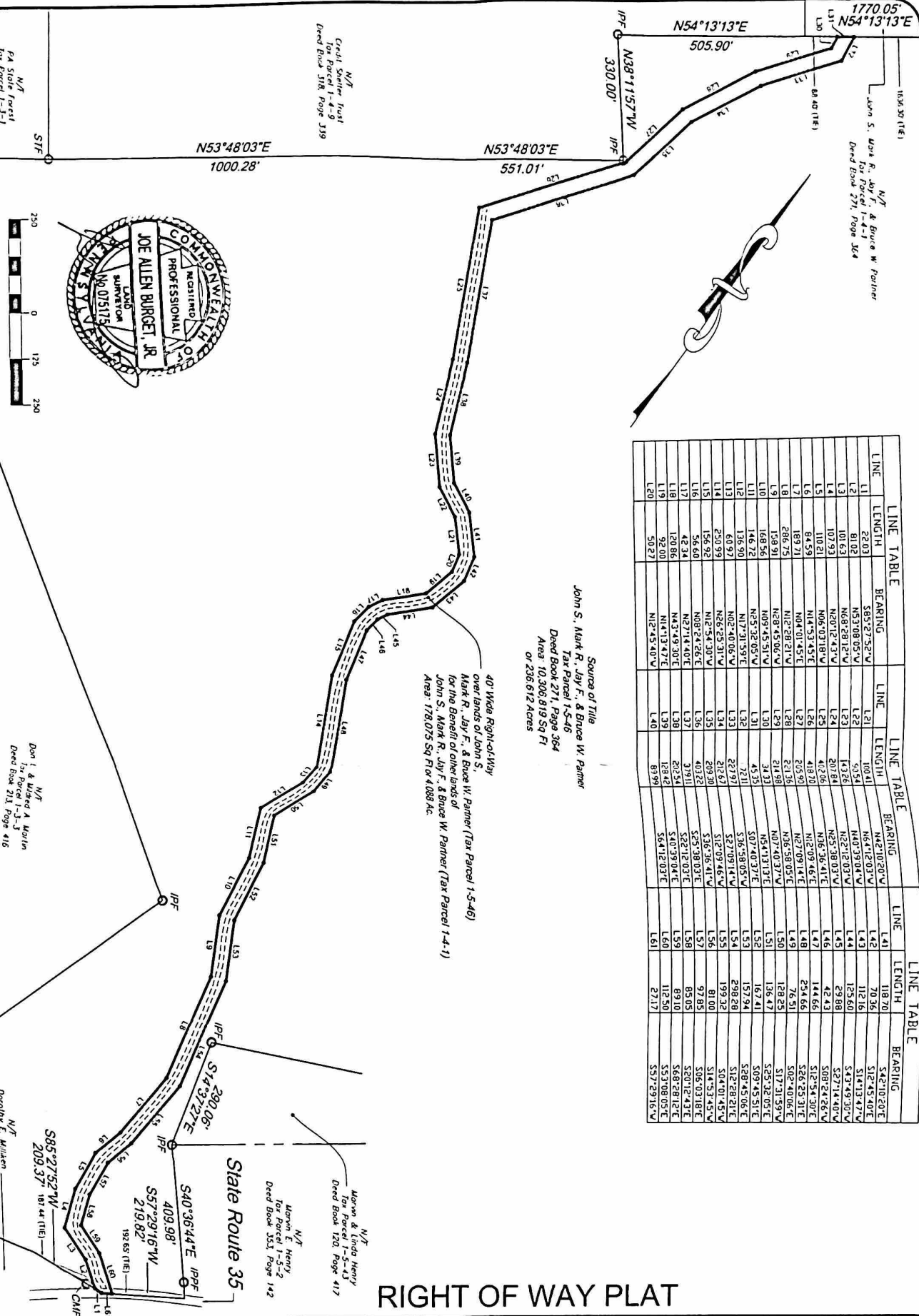

in hand paid, the receipt whereof is hereby acknowledged, the said grantors do hereby grant
and convey to the said grantees, their heirs and assigns

ALL that certain 25 foot wide private right-of-way for ingress and
egress from TR 35 to 200 acre tract of land conveyed from Jessie F.
Partner, et al, to John E. Reisinger, et ux, and recorded
immediately prior hereto, which 25 foot wide private right-of-way
for the purpose of ingress and egress from TR 35 to said 200 acre
tract of land is more particularly described in that certain survey
performed by Stephen P. Reisinger, R.S., on 11-22-88, a copy of
which is attached hereto, marked Exhibit "A", and incorporated
herein by reference thereto and more particularly bounded and

THIS IS A DEED OF RIGHT-OF-WAY ONLY AND NOT OF THE FEE SIMPLE INTEREST IN THE PREMISES FOR THE PURPOSE OF INGRESS AND EGRESS ONLY AND SHALL BE BINDING UPON THE PARTIES HERETO THEIR HEIRS AND ASSIGNS AND SHALL BE CONSIDERED AN EASEMENT APPURIENTANT TO THAT CERTAIN 200 ACRE TRACT CONVEYED TO THE GRANTEES HEREIN BY THE GRANTORS HEREIN AND MAINTENANCE OF SAID RIGHT-OF-WAY SHALL BE THE SOLE RESPONSIBUILITY OF THE GRANTEES HEREIN, THEIR HEIRS AND ASSIGNS.
